THE ANNUAL MEETING STARTED AT 6:30PM, ON WEDNESDAY, NOVEMBER 8<sup>TH</sup>, 2006. IN ATTENDANCE WERE, 5 BOARD MEMBERS, AND 8 RESIDENTS FROM THE SUBDIVISION.

DAN DUFFY OPENED THE MEETING, BELOW WERE DISCUSSED;

- BADE HOUSE STATUS – THE HOUSE HAS NOW BEEN COMPLETELY TORN DOWN; ALL THAT REMAINS IS AN EMPTY LOT. NO PLANS AS OF NOW FOR NEW HOUSE BEING BUILT OR WHAT LOT WILL BE USED FOR, AS IT IS STILL OWNED BY BADE.
- NEW DIRECTOR IS NEEDED – NO VOLUNTEERS AS OF YET, ALL WHO WISH TO APPLY SHOULD CONTACT DAN DUFFY.
- PROPOSED DEVELOPMENT IN WONDER LAKE – NO NEW NEWS OTHER THAN WHAT HAS BEEN PUBLISHED IN THE NEWSPAPER. AN IDEA WAS BROUGHT UP TO ATTEND THE VILLAGE OF WONDER LAKE MEETINGS FOR MORE INFORMATION ON THIS MATTER. DAN WILL FIND OUT WHEN MEETINGS WILL BE HELD FOR THE VILLAGE OF WONDER LAKE.
- PROPOSED WASTE TREATMENT PLANT – NO IDEAS WHERE IT MIGHT BE PLACED AT THIS TIME.
- FAWN LN / FAWN TR – PROBLEM WITH INDIVIDUALS DRIVING MOTORIZED VEHICLES THROUGH THE RETENTION POND AND THROUGH PROPERTIES. SUGGESTED SOLUTION WAS TO CALL THE POLICE IF YOU WITNESS THIS HAPPENING. ASSOCIATION WILL POSSIBLY PUT UP SIGNS ON ALL THE RETENTION PONDS INDICATING “AUTHORIZED VEHICLES ONLY”.
- DITCHES IN FRONT OF PROPERTIES – THIS WAS DISCUSSED AS TO IF HOME OWNERS CAN FIX DITCHES THEMSELVES TO ALLOW PROPER DRAINAGE. DITCHES SHOULD NOT BE CHANGED BY HOMEOWNERS, SHOULD ONLY BE TAKEN CARE OF BY MCHENRY TOWNSHIP.
- WATER TOWER – NO UPDATES YET AS TO IF THIS WILL BE FIXED IN THE NEAR FUTURE.
- ANNUAL GARAGE SALE – TO BE ANNOUNCED AS TO WHAT DATE THIS WILL BE HELD ON IN 2007.
